This refers to your request for clarification and/or confirmation of the news articles entitled "Wilcon Depot Targets 100 Stores, Double-digit Net Income Growth" posted in The Manila Times (Internet Edition) on February 25, 2019. The article reported in part that:

"WILCON Depot Inc. is looking to raise its store network to 100 in the Philippines, its chief said. In a recent interview, Wilcon Chief Executive Officer Lorraine Belo-Cincochan said that although the listed home-improvement and construction-supply company was targeting to reach that number, it was still assessing when that would happen.

Belo-Cincochan said her firm would still eye double-digit growth in its earnings.

We confirm the aforesaid statement of Ms. Lorraine Belo-Cincochan. As published in the company's prospectus one of the key strategies of the company to drive sustainable growth is to expand store network in dominant markets and penetrate fast-growing cities. At present, the company has 52 stores and expansion shall continue in line with the company's objective to remain as the leading home improvement retailer in the Philippines. Moreover, in an earlier press release posted on November 8, 2018, entitled "Wilcon Depot Posts P1.390 Billion Net Income for Nine Months 2018" the company reported that its net income jumped 24.3% y-o-y to P1.390 billion for a net margin of 9.0%. Based from the foregoing results, it is already clear that the company will have a double-digit growth for the year 2018.
